Course Description: Examines legal principles applicable to educational institutions, including federal and state constitutional provisions, legislation, administrative regulations, and case law.¹

Course Objectives: In this course students will:

- 1) Study the U.S. governance system and the role of the courts in education.
- 2) Explore relevant theories of government, politics, and jurisprudential ideals.
- 3) Study the role of law in the establishment and implementation of public policy governing educational institutions.
- 4) Review applicable federal and state constitutional provisions.
- 5) Review court decisions, statutory law, and administrative regulations concerning educational institutions, students, teachers, etc.
- 6) Debate and reflect on legal principles and their application in educational institutions.
- 7) Engage in legal research, and present and debate their findings on legal research problems related to educational institutions.

Course Outline: Below is an outline of topics covered:

- 1) Course introduction and overview.
- 2) Governance structures and the legal system.
- 3) School funding litigation: equity and politics.
- 4) Compulsory school attendance.
- 5) Church and State relations.
- 6) Curriculum censorship.
- 7) Student freedom of expression.
- 8) Student discipline and due process.
