2. Resident Instruction and Continuing Education

Since my appointment at UGA in 1999, I have taught 15 unique EDIT courses, 5 of which were offered on-line, 1 online EADU course, 1 freshman seminar for the university (FRES), and 1 QUAL course. Enrollment in the courses ranges from 5 to 61. Learner evaluations in the courses have generally been above average, with values ranging from 4 to 4.9 for *teaching ability* (average 4.5) and 3.3 to 4.8 for *overall value of the course* (average 4.4) (see Table 1 for a summary of courses taught). Learner comments, gathered from mid-term and end-of-term evaluations, have generally been very positive.
